ON 01/06/11 at 0240 hours C1 flagged down a 3rd district Officer to report an assault that took place inside Josphine's Nightclub at 1008 Vermont Ave. a 1D Investigator responsed and interviewed C1. C1 reported that she was grabbed by S1 by the wrist who was saying "fuck you Bitch". C1 reacted by throwing a drink in S1's face. C1 then said S1 was lead away by his bodyguards. C1 started back dancing with her friends again on the other side of the club. A few minutes later C1 said S1 came up from behind her and threw a drink on her causing her clothes to be wet. S1 also said she substained a cut to the inside of her lip when S1 did this to her. The Investigator reviewed the video cameras that showed S1 approach C1 and reach for her in a calm manner but C1 responded by throwing a drink in his face. S1 then was escorted away by his bodyguards at 0101 bours. S1 went back over to C1 at 0106 hours carrying a plastic bottle with unknown liquid and threw the liquid in C1's face, then tossed the container at her body not causing any injuries. C1 attempted to go after S1 but was prevented by people in between them. The camera shows C1 being elbowed by accident which caused the cut to her lip.C1 reports she only knows S1 because of her work with Nfl players and they have never dated. C1 also stated she asked the club manager to call the police but he declined and asked her to just calm down because everything was over.
