On the above listed date and time was given several verbal commands to leave the roadway. Both cars and buses were attempting to use the area at 2216 MLK ave, SE. S-1 was apart of "EmPowerdc" demonstration which caused a Blockage of Passage for motorists in 2600 blk of MLK ave, SE. S-1 was given 3 loud and clear verbal commands by MPD officials to clear the roadway, at which time S-1 refused all 3 commands. Mpd officer conducted a stop of S-1 without incident and was placed under arrest for Blocking Passage, placed in handcuffs and transported to 7d for processing.

While on the scene c-2 observed S-1 being detained and attempted to approach MPD officers, at which time officers on the scene conducted a stop, identified C-2 "verbally" and sent C-2 on her way.
