Activities/Contacts/Appointments log: He indicated that he spoke with Ms. C via telephone on an almost daily basis. In regards to his internet usage, Mr. Hinckley noted the websites he visited on July 16, 2014. He reported purchasing items for himself; including three shirts and a pair of pants, and cat food for the feral community he cares for on the Hospital grounds. Mr. Hinckley also noted that he purchased a shirt for Ms. C.

A post-visit interview was conducted with Mr. Hinckley. He stated, "I did everything I was supposed to do. We continue to be met with rejection after rejection. Everyone keeps telling me to keep my chin up. I'm trying... this is nothing new. Since day one in Williamsburg I've been faced with this stuff." He discussed the past rejections he has encountered from individuals, groups and organizations since beginning his trips to Virginia. In contrast, he mentioned, "...except at Eastern State." With regards to his relationships, Mr. Hinckley also discussed the "Dear John" letter he received from Ms. N while he was at home this month; and talked about how he is managing this loss. He stated that "it wasn't a big surprise" given that he had not heard from her in several weeks. Mr. Hinckley was able to recount the numerous rejections he received during the month of July and the ways in which he coped with the consequent feelings conjured by each experience. Mr. Hinckley noted that despite the ongoing issues related to the enmity within some portions of the Williamsburg community towards his attempts at reintegration, he continues to be determined to work towards the goal of living in this area.

Post-visit interviews were conducted via telephone with Mrs. Hinckley and in person with Ms. Diane Sims. Mrs. Hinckley reported, "It was a good visit, and it was so nice to have Diane here with John. Everything has just gone wonderfully well. As you know we're getting ready for this weekend!" In relation to the rejections faced by Mr. Hinckley this month, Mrs. Hinckley replied, "Well, I know I said things were good, but as far as these things go...I was worried that some of these rejections would be coming. John's father and I had gone to the Heritage Humane Society years ago and it was plain back then that they weren't going to accept him....! didn't even know that Botanical Garden was even there... He took it very well. I didn't see any mood change. You know how you would feel if you were rejected... he felt that too." Mrs. Hinckley reiterated the difficulty she is having bearing the many costs associated with the various services Mr. Hinckley must access, from a car service to weekly individual and group therapies to case management, etc. It was discussed that Mr. Hinckley should be contributing some of the income from his WATP position at the Hospital to help defer some of these costs, even nominally. Mrs. Hinckley also asked for future itineraries to spread out some activities and appointments, when able. On the Individualized Relapse Prevention Plan Feedback Form, Mrs. Hinckley did not endorse any behaviors or symptoms as observed. She chose to write in the additional comments section. She summarized the appointments her son kept during this visit. She also wrote, "John's sister, Mrs. Diane Sims, from joined us [at] the end of his visit and the three of us enjoyed three days of family catch-up and bonding. It was a very busy, wonderful Williamsburg visit for John."

Mrs. Sims was interviewed by members of Mr. Hinckley's treatment team upon her arrival at the Hospital on July 28, 2014. Mrs. Sims highlighted the aspects of her brother's new visits that she notes as improvements and developments since her last visit to Virginia. In particular she discussed his independent driving and use of his food handler's license at Eastern State Hospital as having given him "more self-confidence." Further, she talked about Mr. Hinckley's helpfulness around the house completing the carious chores and increasing his assistance with

On Tuesday, July 22, 2014, after breakfast, Mr. Hinckley utilized unaccompanied free time to exercise at the Community Center. In the afternoon, he made lunch for himself and his mother, completed chores and engaged in leisure activities. That evening, he ate dinner at home before driving to his 6:30 p.m. group therapy session. He independently drove home at the end of this group.

On Wednesday, July 23, 2014, Mr. Hinckley took a morning walk around Kingsmill. After lunch he helped his mother clean the house and complete other necessary household management tasks. Due to a late cancellation by the Heritage Humane Society, Mr. Hinckley spent the rest of the day at home. He later prepared dinner for his mother and they spent the remainder of the evening relaxing at home. Mr. Hyde received notice on this day that the Music Therapy session originally scheduled for Sunday, July 27 needed to be rescheduled to Thursday, July 24. The Secret Service was informed of the last minute changes.

On Thursday, July 24, 2014, Mr. Hinckley volunteered his time at Eastern State Hospital. After work, he drove home for lunch. While at work, he was informed that there would be no supervisors present at the canteen on the following day, so his work would be cancelled for the next day. He immediately called Mr. Hyde to inform him of this unexpected change to the itinerary for July 25. In the afternoon, Mr. Hinckley utilized unaccompanied free time to go grocery shopping for his mother. At 5:00 p.m., Ms. Haley came to the family home to provide a music therapy session for Mr. Hinckley. This was a last minute change in itinerary due to a conflict Ms. Haley had on the originally scheduled day and time. Due to a revoked invitation to volunteer for the ARC of Greater Williamsburg, Mr. Hinckley spent the remainder of the evening preparing and enjoying dinner with mother, taking out the garbage, and engaging in Arts-related pursuits. Again, Mr. Hyde notified the Secret Service of the changes in schedule as we learned of them.

On Friday, July 25, 2014, Mr. Hinckley spent the morning at home with his mother. He picked up the newspaper and mail, and dealt with the garbage and recycling for the day. Around noon, he drove to meet Mr. Weiss at the Sportsman's Grille to have a case management session. He returned home at the end of this meeting. In the afternoon, he and his mother went shopping at Belk's Department Store and PetSmart. The remainder of the evening was spent at home.

On Saturday, July 26, 2014, after breakfast, Mr. Hinckley drove to his 10:00 a.m. appointment with Dr. Giorgi-Guarnieri. He independently returned home to prepare for his sister's arrival. The family ate dinner at a local restaurant and spent the rest of the evening at home.

On Sunday, July 27, 2014, Mr. Hinckley took a walk around Kingsmill. In the afternoon, Mr. Hinckley socialized with his mother and sister. In the evening, Mr. Hinckley and his family prepared and enjoyed a meal together at home. The rest of the evening was spent preparing for the following day's departure.

On Monday, July 28, 2014, after breakfast, Mr. Hinckley was escorted back to Saint Elizabeths Hospital by Mrs. Diane Simms. He was received by Hospital staff at 2:00 p.m.

In terms of completing the Individualized Relapse Prevention Plan Feedback Forms, no items were endorsed by Mr. Hinckley or his family members. In the "Additional Comments" section, he chose to write, "Nice time at home." Mr. Hinckley also completed his weekly
