

"decimated" by healthcare reform and therefore, the family is facing more financial challenges than they once did.

Mrs. Sims affirmed that she would be an active participant in treatment plans if Mr. Hinckley were granted convalescent leave. Mrs. Sims agreed that if their mother passed away, she would consider coming to Williamsburg for a temporary stay to support Mr. Hinckley through this transition. She mentioned this would be most likely to accommodate this arrangement if it were to occur after her husband retires. Mrs. Sims described the possibility of Mr. Hinckley one day relocating to Texas as "not ideal." She pointed out that he would have "no connection" to the treatment providers in Texas, and that "communication between Dallas and Saint E's is not viable."

Josna Hinckley, Mr. Hinckley's mother

Mrs. Hinckley began the interview by commenting, "I just miss him [Mr. Hinckley] so much when he leaves and can hardly wait for him to come back. Everything has gone well and I will give the thanks all to John. He has everything under control and he is so good about all of his appointments and I never have to remind him of an appointment. He leaves early for his appointments. No one has tried harder than him. I'm in awe of him and he is just the nicest person to have in the house...He is so ready for this and he has tried so hard to do everything perfectly."

Mrs. Hinckley denied any changes in Mr. Hinckley's mood. When the topic was raised, she noted that he has always been a quiet person, even as a child. She recalled him coping well with the possibility of being charged with James Brady's death. She explained that he did not seem to worry excessively about it and the family reassured each other that "everything was going to be all right." Mrs. Hinckley explained that Mr. Hinckley keeps active during his visits and has appointments "morning, noon and night." She reported that during down time at home, he typically spends time in his room working with music equipment he has set up in his room. He also takes time to feed swans that swim in a pond just outside of their home.

Mrs. Hinckley discussed her interactions with Mr. Hinckley's female acquaintance in Williamsburg, Ms. L. She estimated Ms. L having been over to her home three or four times. She also met Ms. L's parents, who she described as "lovely people," when they have dropped her off and picked her up at the Hinckley residence. Mrs. Hinckley indicated that Ms. L is a "delightful guest to have," and that Ms. L's parents have become fond of Mr. Hinckley. She noted that they typically play music or watch television together. When asked about Ms. CB, Mrs. Hinckley talked about her mental health issues and held her position that she does not want Ms. CB to visit Williamsburg.

Mrs. Hinckley reported that she has been "so blessed with good health." She indicated that she keeps regular doctors appointments every six months and has not suffered from any medical problems aside from mild hypertension that is well controlled by medication. Moving forward, Mrs. Hinckley provided assurance that the family is "still prepared to cover any costs, or whatever it takes." She also mentioned that while she has had a hard
