be "costly." He added that he, himself, accepts Medicare as a private practice practitioner, but does not accept Medicaid. He also felt that the hospital treatment team should seek clarity from Scott Hinckley about what the living arrangements would be if Mrs. Hinckley's health declines. He thought the plan would be for Diane to stay with Mr. Hinckley in the family home until an alternative situation was located. He was uncertain if Scott Hinckley would provide additional financial support of Mr. Hinckley if they sold the family home.

Mr. Beffia confirmed that the Williamsburg treatment team has held treatment plans, on approximately three or four occasions. The meetings have included Mr. Weiss, Mr. Beffia and Dr. Giorgi-Guarnieri. Ms. Haley has been unable to attend some of these meetings and he mentioned that overall, coordinating with her has been a challenge.

Mr. Beffa described his clinical impressions of Mr. Hinckley in individual and group therapy. He commented, "His mood has continued to improve dramatically. In the past, he has been subdued. Not flat, but not much energy behind his smile or facial expressions. He's amiling more, he's laughing and joking and is more upbeat." When saked to recall Mr. Hinckley's reaction to James Brady's passing, Mr. Baffa described Mr. Hinckley feeling "remorseful and sad" about the negative impact he had on Mr. Brady and his family's life. He expressed some concern to Mr. Beffa about being charged with homicide, but was reassured by Mr. Levine that it would be unlikely that charges would be laid.

An update of Mr. Hinckley's relationships with women was discussed with Mr. Beffa. With respect to Ms., CB, Mr. Beffa explained:

He [John] has been concerned about her. He is knowledgeable and rational about her, about the fact that she is, in his words, 'high maintenance.' She is fragile and does not keep up with her own needs in terms of her mental health. He knows she will continue to relapse. He decided in January or February of 2014 to distance himself. They remained friends, pursued daily phone calls and/or visits. She talked about a Christmas visit and wanted to look into the possibility of moving there. John does not see this as a positive situation because she would want to be taking up all of his time.

It was Mr. Beffa's impression that Mr. Hinckley has been "open and honest" with Ms. CB. Mr. Beffa pointed out that Ms. CB and Ms. N met one another when Ms. CB was visiting Mr. Hinckley and Ms. N approached them while using her grounds privileges. Mr. Beffa noted that Mr. Hinckley and Ms. N were "an item" for about two or three months. She gave cologne and a shirt to him on his birthday. Not long after, she "disappeared." Mr. Beffa recalled Mr. Hinckley was initially unsure of how to reach out to Ms. N when she discontinued contact. He wrote a short note to her, asking if they could be friends if they could not be together. Mr. Beffa described Mr. Hinckley as "sad and regretting what occurred. He was a little dismayed but there was not much he could do about it."
